Thank you for contacting Jamison Legal Group to help you improve your credit.

BEFORE YOU HIRE US:

Please understand that for us to give you updated credit advice letters and continued complimentary credit repair, it is vital that you keep your IdentityIQ subscription active. We can only give you services based upon the most recent copy of your IdentityIQ 3-Bureau credit report. IdentityIQ is a separate company that you are subscribing to. If you want to cancel your IdentityIQ subscription in the future, you need to cancel it directly with them by calling 877-875-4347. We require IdentityIQ credit reports because our software was designed to import their format. IdentityIQ credit reports are also considered soft-inquiries that don't hurt your credit score.

CLIENT AGREEMENT

FEE AGREEMENT

This agreement is in response to client's desire to retain Jamison Legal Group for professional credit services that include unlimited credit advice letters in addition to the advice letter we give client on day 1 AND Identity Theft Protection for client's entire household where Jamison Legal Group will work on clearing any and all fraud from Client's or their household member's credit report should they ever become a victim of Identity Theft while they are paying our monthly fee for the unlimited credit advice letters. If Client doesn't cancel our unlimited credit advice service for at least 5 months, Jamison Legal Group agrees to provide Client and their entire household Identity Theft Protection for the life of Client. Purchasers of our unlimited Credit Advice Letter service can also request that we remove or correct their negative credit items at no additional charge to our monthly service fee we are charging for the credit advice letters and household identity Theft Protection. You can request a new updated credit advice letter based off your most recent IdentityIQ 3-Bureau credit report at any time by going to <https://jamisonlegalgroup.info/update>

ITEMS NOT TO BE NEGOTIATED

For Clients that opt to use our complimentary dispute service, the undersigned agrees as follows. I (the client) believe that all negative items which appear on my consumer credit reports may not be accurate, timely, or verifiable and I want Jamison Legal Group to attempt to get them deleted or verified as being accurate. I agree to email a list of the negative items that I feel are 100% accurate and verifiable to DoNotDisputeThese@jamisonlegalgroup.com. I understand that the items I email to that address will not be disputed or attempted to be removed and will remain. (If you do not email a list of any items and if you told us you wanted us to dispute your negatives, we will assume that all negative items are inaccurate and should be disputed.) Unless otherwise instructed by you via an email to DoNotDisputeThese@jamisonlegalgroup.com, Jamison Legal Group will assume that the reason you are asking us to dispute the negative items that appear on your credit reports falls under one or more of the following categories:

- I do not recall these listings as they are being reported.
- I do not believe these listings are being reported accurately.
- I think that I may be a victim of Identity Theft.
- The status of these listings isn't accurate, and they may not belong to me.
- I do not believe these listings are verifiable.
- I believe there may be a file mix-up with another person.
- I was never late on this account.

Attorney Client Relationship

If in the future client becomes a victim of Identity Theft, or if Jamison Legal Group and Client decide to pursue a lawsuit against the credit bureaus and/or creditors, client would need to sign a separate retainer agreement with an Attorney that may or

may not be employed by Jamison Legal Group. This current agreement in no way creates an Attorney Client relationship between Client and anyone at Jamison Legal Group. A separate agreement would need to be drafted and signed to create an Attorney/Client relationship and client agrees that this agreement does not create that Attorney Client relationship in any way.

Fees for Services/ Cancellations

Client agrees to allow Jamison Legal Group “a division of Identity Theft Solutions LLC, a Nevada LLC” to charge their credit or debit card they gave us during the recorded sales call a \$149 set-up fee (includes 1 year of Identity Theft coverage for the entire Household) and \$99 per month for the service. The \$99 will be charged on either the 1st or the 15th no sooner than 30 days after the initial charge of \$149, depending on the date the Client signs-up. For example; if client signs up on the June 20th, they will be charged the \$149 set-up fee on June 20th but won’t be charged \$99 until August 1st (40 days later). They will be charged \$99 every 1st of the month thereafter until they cancel by sending us an email to cancel@jamisonlegalgroup.com or texting “cancel” to 561-444-9669. If Client signs up and pays \$149 on June 14th, they wouldn’t be charged \$99 until July 15th (31 days later in this example.) Client can cancel our service at any time and not be charged again in the future. All charges are considered non-refundable once charged to Client’s credit or debit card. For the \$99 monthly fee, Client will get unlimited credit advice letters and get identity Theft Protection for Client and their entire household. If Client keeps their paid membership for at least 5 months, Jamison Legal Group will cover Client’s entire household against Identity Theft for the life of Client. Should Client cancel the unlimited credit advice letter service before 5 monthly payments of \$99 have been made, the Identity Theft Protection will cover only the Client for a period of 1 year per \$99 they paid and not cover any household members after the cancellation is effective once the initial year and earned months expires. The \$149 set-up fee includes Identity Theft Protection for the entire household for a period of 1 year no matter when Client cancels. This coverage is not insurance but is considered a complete waiver of our fees where Jamison Legal Group will work at no charge to remove fraud items from Client’s credit reports that resulted from identity Theft for Client and all household members. Typical insurance benefits like reimbursement for lost wages or expenses is not provided by Jamison Legal Group, we are only doing the work to clean the credit report at no cost to client or their household members should they become a victim in the future.
